Survey conducted January 8 to January 9, 2022. 1,011 likely 2022 General Election voters participated in the survey. Survey weighted to match expected turnout demographics for the 2022 General Election. Margin of Error is +/-3% with a 95% level of confidence. Totals do not always equal 100% due to rounding.
